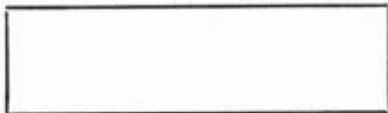


**BE SURE**

(in this case a special form must be used).
- ★ That the tattoo markings stated on this form are exactly the same as those in the ear of the animal.
- ★ That all signatures are in ink.
- ★ That all information is filled in, in ink or typewritten.
