#### WHOLE HERD REGISTRY ANNUAL ENROLMENT

(On each animal of enrollment age (female - 16 months and males - 30 months on inventory date) which makes the animal active for the current year and entitles the breeder to:

- \*Listing of all active cows and bulls within the WHR herd.
- \*Registration of each female's calf within 12 months of calving. This includes multiple births (see WHR regulations #10 in regard to embryos). See fees below for calves over 12 months of age.
- \*Transfer of the WHR listed animal during the year of enrolment.
- \*Transfer of the calf (calves) to a new owner (females up to 24 months, males up to 30 months). Transfers of progeny over these ages will be at regular rates.
- \*Report of birth, weaning and yearling weights at no charge.
- \*Transaction fee will be waived for business transactions in WHR herds.
