Information will be kept on file with the NAPA Registrar, and no certificate will be issued for the animal. The information will include owner at birth, unique tattoo, animal birth date, sex, breed composition and pedigree as supplied by the breeder. No DNA Myostatin or Permanent Record Test will be required, and no warranty of the myostatin or pedigree accuracy of the animal will be implied. First Cross animals will be issued a unique ID number by the Registrar, printed on the receipt of work processed. These animals can be assumed to be 1-copy for Myostatin, as they must have one parent fully registered with NAPA carrying 2-copies of the gene. When these First Cross animals produce offspring, the offspring may then be registered or recorded in the Naturalean N category bringing forward the breeder's record pedigree as given for the First Cross animal, if the offspring meet the requirements for registry in the Naturalean N Category as follows: one parent must be a fully registered or recorded animal; the applicant animal must have the DNA Myostatin Test on file confirming 1 or 2 copies of the Myostatin gene.

The \$10. fee/non-Piedmontese registered parent is a 1-time only fee (ie. if you have 10 calves sired by a reg. Angus bull, you pay \$10. once to record his pedigree for all calves.) Enclose photocopies of all non-Piedmontese registered animals pedigree certificates.
