#### CONSTITUTION

#### 1. NAME

The Association shall be the: "CANADIAN PALOMINO HORSE ASSOCIATION".

#### 2. OBJECTS

The Association shall have for its object the encouragement, development and registration of the breeding of Palomino horses in Canada.

- (a) By keeping a record of the breeding and origin of Palomino horses and by collecting, preserving and publishing data and documents relating to same.
- (b) By establishing standards of breeding and by carrying out a system of registration under the Canadian National Live Stock Records system.
- (c) By adopting means from time to time to protect and assist breeders engaged in propagation and breeding of purebred Palomino horses in compliance with the Livestock Pedigree Act or any regulation made thereunder.
  - (d) By maintaining an efficient inspection of same and to prevent, detect and punish fraud.
- (e) By compiling statistics of the industry and furnishing official and authentic information in regard thereto.
- (f) And for these purposes to make all needful contracts and agreements and to make, alter and repeal regulations subject to the provisions hereinafter set forth.

#### 3. MEMBERS

- (a) <u>Types of Membership</u> There shall be three types of memberships:
- (i) <u>Honorary Members</u>: The Association may appoint Honorary life Members at a general meeting if the Board of Directors have by resolution named the proposed member or members and recommended that such appointment be made. But such Honorary Member shall take no part in the management of the Association's affairs. Their position shall be purely Honorary.
- (ii) <u>Life Members</u> Life Members shall be those individuals who have paid a life membership fee of \$75.00.
- (iii)<u>Annual Members</u> Annual Members shall be those individuals, partnerships or companies, resident in Canada, who pay the prescribed annual membership fee due the 1st day of January each year. The annual membership fee shall be \$15.00.
- (b) Application for annual membership shall be in writing. Each applicant on becoming a member shall agree to be bound by the Constitution and amendments thereto and all Rules of the Association, but the Association shall have power to reject any application for membership.

Application for partnership or incorporated company membership shall specify the person authorized to vote, act, or sign for the partnership or company. A member of a partnership or company other than the person mentioned in the application may be authorized by the partnership or company to act or vote at any meeting of the Association.

All members in good standing shall, as a matter of contract and except as hereinafter provided, enjoy the same rights and privileges and be subject to the same liabilities as the original incorporators of this Association. No member who is in arrears of membership or other fees or dues shall enjoy such rights and privileges.

A member in good standing is a member who has complied with the regulations as hereinafter set forth and who is not in arrears of membership or other fees or dues or suspended.

The financial liability of the member to the Association shall be limited to the amount due from him in respect to his membership and registration fees.

A member may, provided he is not in arrears for membership or other fees or dues, at any time resign from membership in the Association by giving notice in writing to the Secretary of his intention to do so, but membership shall not terminate until the end of the then current membership year.

No member shall be entitled to any of the rights and privileges of the Association during any year until his annual fee for that year is paid. On December 31st in each year all members who paid for the preceding Association year, but who have not paid for the then current year, shall be removed from the membership roll. They may nevertheless again become members in the manner prescribed by this Constitution.

No member shall hold office or be entitled to vote at a meeting or to give notice to amend this Constitution if at the time in arrears of membership or other fees or dues, and no applicant shall be entitled to vote until his application for membership has been accepted.

The Board of Directors shall have the power to suspend or expel any member who fails to observe any rule or regulation set forth in this Constitution or whose conduct is, in the opinion of the Board, prejudicial to the interests of the Association. A member so suspended or expelled, after the expiration of sixty days has the right to apply to the Board of Directors for reinstatement, and shall, on application, be reinstated at the next meeting of the Board provided two-thirds of the members of the Board present thereat vote in the affirmative. If the Board of Directors refuses to reinstate a person suspended or expelled from membership, such person shall have the right to apply for reinstatement by the next succeeding general meeting, but reinstatement by a general meeting shall be only by a vote of two-thirds of the members present thereat and voting. Any person expelled from membership by any other Association incorporated under the Livestock Pedigree Act shall not be eligible for membership in this Association and if he is a member at the time of such expulsion his membership shall thereupon forthwith terminate automatically.

On report of the Executive Committee of a charge against any person which may result in suspension or expulsion, the charge shall be laid before a meeting of the Executive Committee and the person so charged shall have fifteen days notice in writing of such meeting and be given the right to be heard.

The membership year and the fiscal year of the Association shall be January 1st to December 31st.

#### 4. OFFICES

The Head Office of the Association shall be at such place as the Board of Directors may determine and the office for the registration of pedigrees shall be the office of the Canadian National Live Stock Records, in the City of Ottawa, Ontario, under the supervision of the Record Committee of the Canadian National Live Stock Record Board.

#### 5. OFFICERS

#### (a)Directors

Except as hereinafter otherwise provided, the affairs of the Association shall be conducted by a Board of six Directors consisting of the President, Vice-President and four Directors, who shall hold office for two years or until their successors are elected.

The Directors shall be elected from each province or group of provinces as follows: British Columbia, one; Alberta, one; Saskatchewan, one; Manitoba, one; Ontario, Quebec, New Brunswick, Nova Scotia, Prince Edward Island and Newfoundland which shall, for the purpose of this Association, be considered as one province and shall be known as Ontario, Quebec and the Maritime Provinces, two.

The President and Vice-President shall be elected by the Board of Directors from members of the said Board at a meeting immediately following adjournment of the annual meeting. In the case of a tie vote, the Presiding Officer shall have a casting vote.

The Directors for the province or group of provinces in which the Annual Meeting is held in each election year shall be elected at such annual meetings by the members of the Association resident in such province or group of provinces, present and voting. In the case of a tie vote the President or other presiding officer shall have the casting vote.

Directors for the other provinces shall be elected in the following manner:

Between the fifteenth and thirty-first day of December in each election year the Secretary of this Association by post prepaid shall send to each of the members of the Association in good standing on the thirtieth day of November resident in each province, respectively, a complete list of the members in good standing resident in such province or group of provinces, together with a proper voting paper bearing the seal of this Association on which each member may write the name of the member whom he desires to be Director for his province, or group of provinces, and forward same to the Secretary. Only those votes shall be counted which shall have been received by the Secretary on or before the twenty-fifth day of January next following.

A member in good standing for the purpose of this ballot is one whose membership fee for the current year and arrears have been received by the Secretary.

Prior to the next Annual Meeting, the Secretary shall, in the presence of a Notary Public, open the envelopes containing the ballots and proceed to count the number of ballots in each case, and the member receiving the greatest number of votes shall be the Director for his respective province, or group of provinces, for the ensuing year. In the case of a tie vote, the Secretary shall have a casting vote.

A certificate of the result of the voting shall be signed by the Secretary and attested by the said Notary, under his signature and seal.

The Directors shall have the power to fill vacancies which may occur among the officers through resignation or death.

#### (b) President

The President shall hold office for two years or until his successor is elected. The duties of the President shall be to preside at all meetings of the Association and the Board of Directors and of the Executive Committee, to exercise a general supervision over the affairs of the Association, and generally to do all matters, acts and things as are usually done by Presidents of similar organizations. He shall be a member of all Committees.

#### (c) Vice-President

The Vice-President shall hold office for a similar term, and in his absence, perform all the duties of the President.

#### (d) Secretary-Treasurer

The Board of Directors shall from time to time as occasion may require appoint a Secretary and a Treasurer, or a Secretary-Treasurer, who shall act under the control and with the approval of the Board of Directors. The duties of the Secretary shall be to attend all meetings of the Association and the Board of Directors and of the Executive Committee and to keep exact Minutes of the Proceedings of same and to do such other things as may be delegated to him by this Constitution, the Board of Directors or the Executive Committee.

The Treasurer shall deposit all monies received by him in a chartered bank to the credit of this Association, and shall pay same out again by cheque only, countersigned by the President. He shall deposit for safekeeping all securities owned by this Association in a safety deposit vault as may be approved by the Board of Directors and shall withdraw the same only on the order of the President or other officer named by the Board of Directors. He shall be bonded in such amount as may be required from time to time by the Board of Directors. He shall keep proper books of account containing entries of all such matters or things as are usually entered in books of account, and shall from time to time furnish statements in detail of the affairs of the Association or such other matters as may be directed by the Board of Directors or the Executive Committee.

#### (e) Auditor

The Association at each Annual General Meeting shall appoint an Auditor, or Auditors, and fix their remuneration. His duty shall be to examine the books of account of the Association, vouchers for all payments and certify the usual statements of receipts and expenditures and assets and liabilities, for the year, for presentation to the next Annual General Meeting.

## (f) Registrar

The Canadian National Live Stock Record Committee shall assign to this Association a person to act as Registrar. The duties of the Registrar shall be similar to the duties of other Registrars in the employ of the Canadian National Live Stock Records.

## (g) Pedigree Committee

The President, or his representative, the Secretary and the Registrar shall be a Committee to authorize change of ownership and registration of pedigree where signatures or other information are for any reason unobtainable. The decision of the Committee shall, if unanimous, be final. If the Committee is not unanimous, the matter in question shall be submitted to the Board of Directors for decision. This Committee or the Board of Directors shall have no power to authorize the registration of any animal, unless the pedigree of breeding submitted complies in all particulars with the rules of eligibility for registration as outlined elsewhere in this Constitution. All decisions of the Committee shall be submitted to the Board of Directors and shall be incorporated in the minutes of their next meeting.

## (h) Executive Committee

The Directors shall at their first meeting after each annual general meeting elect by ballot three of their number to act on the Executive Committee who, together with the President and Vice-President, shall constitute this Committee. A copy of the minutes of each executive meeting shall be forwarded to each Director and to the Director of the Canadian National Live Stock Records within ten days after the meeting.

## (i) Representatives

Representatives to organizations asking that such be appointed shall be appointed at the Annual General Meeting but if for any reason any of these are not appointed, the Board of Directors shall have power to appoint the same. Representatives to the Canadian National Live Stock Record Board shall be appointed by the Board of Directors.

## (j) Provincial Clubs

Members of this Association in good standing may organize Provincial Clubs under a Constitution approved by the Board of Directors. The activities of any such Provincial Club shall be confined solely to its own provincial interests and shall not conflict in any way with the activities of this Association. Not more than one Provincial Club in each Province shall be organized.

#### 6. MEETINGS

The Annual General Meeting of the Association shall be held at such time and place as decided upon by the Board of Directors of the Association. Other general meetings shall be held at the time and place fixed by the Board of Directors or Executive Committee. A notice at least thirty days in advance shall be given by post, indicating the time and place of meeting. This notice shall be given by a circular letter postage prepaid to each of the members at his last known post office address appearing on the books of the Association. In the event of the Association publishing an official organ a notice published therein shall be deemed to be sufficient.

A copy of the notice calling an annual or general meeting shall be forwarded to the Minister of Agriculture for Canada and to the Director, Canadian National Live Stock Records, in a like manner as to members of the Association.

Notice of meetings of the Board of Directors other than the one immediately following the Annual General Meeting shall be mailed postage prepaid to each one of them ten days at least before the date of meeting to his last known post office address appearing on the books of the Association or by telegraph at least seven days before the date of the meeting.

A meeting of the Board of Directors may be held on shorter notice or without written notice providing all Directors have given their consent to the meeting being held. A minute of each consent shall be entered in the Minutes.

Notice of the meetings of the Executive Committee shall be mailed postage prepaid to each member thereof five days at least before the date of the meeting to his last known post office address appearing on the books of the Association.

Meetings of the Executive Committee may be held on shorter notice or without written notice providing all have given their consent to the meeting being held. A minute of such consent shall be entered in the minutes.

For the transaction of the business of the Association at an Annual or other General Meeting a quorum shall be ten, at a meeting of the Board of Directors a quorum shall be three.

A copy of the Minutes of all Meetings of the Board of Directors and of the Executive Committee shall be mailed within ten days following such meetings to each Director and to the Director, Canadian National Live Stock Records. Such minutes shall stand approved if no objection is raised within seven days by anyone who was in attendance at such meeting.

#### 7. ORDER OF BUSINESS

The order of business at all Annual and General Meetings shall be as follows:

- 1. Identification of Members.
- 2. Reading Minutes of previous meeting.
- 3. Reports of officers, directors and committees.
- 4. Correspondence.
- 5. Unfinished business.
- 6. If Annual Meeting, election of directors and other officers.
- 7. New business.
- 8. Adjournment.

The above order with the exception of (1.) Identification of Members, may be changed at the pleasure of the meeting assembled.

#### 8. AUDIT AND ANNUAL REPORT

The Board of Directors at each Annual General Meeting shall submit a complete report of its acts and of the affairs of the Association. It shall present a detailed statement duly audited of the receipts and expenditures of the preceding year and of the assets and liabilities of the Association.

A copy of this report, a list of the officers elected and the representatives to the Canadian National Live Stock Records Board, also general information on the affairs of the Association shall be sent to the Minister of Agriculture for Canada and to the Director, Canadian National Live Stock Records, within 20 days after the Annual Meeting. A copy of the Annual Report shall be mailed to each member in good standing.

#### 9. EXPENSES, INCOME AND PROPERTY

The income and property of the Association from whatever source derived, shall be applied solely towards the promotion and furtherance of the objects of the Association and no part thereof shall be paid or transferred directly or indirectly by way of bonus or otherwise as profit or gain to members of the Association, past, present or future, or to any person claiming through any members, provided however that nothing herein contained shall prevent the bonafide payment of remuneration to any Secretary, Treasurer, Registrar, Officer, Clerk or Servant or other person or persons for services actually rendered the Association whether such are members of the Association or not, and the expenses of the Directors or other Officers incurred in doing the business of the Association.

The Association shall with other organizations comprising the Canadian National Live Stock Records, pay to the Record Committee of the Canadian National Live Stock Record Board, a proportionate amount of the expense of conducting the Canadian National Live Stock Records office.

#### 10. BOOKS

The Association shall cause a book to be kept by the Secretary and by the Secretary of each Provincial Club, if any, wherein shall be contained a copy of the Constitution so that persons becoming members of the Association may at all reasonable times examine same.

#### 11. AMENDMENTS

This Constitution may be amended at any general meeting of the Association by the affirmative vote of two-thirds of the members present, but no amendment shall be valid until approved by the Minister of Agriculture for Canada, and filed at the Department of Agriculture for Canada. Notice of all proposed amendments shall be given to the Secretary sixty days in advance of a general meeting and they shall be included in the Notice calling such Meeting, otherwise they shall have no power to deal with same.

#### 12. DISPOSITION OF FEES

- (a) All fees shall be paid to the Accountant, Canadian National Live Stock Records and may be sent by Postal Note, Post Office Money Order, Express Money Order, Bank Money Order or Certified Cheque, payable at par in Ottawa, Ontario, and they shall forthwith be deposited by him to the credit of the Association in a chartered bank, selected by the Record Committee of the Canadian National Live Stock Record Board.
- (b) In case membership fees to the Association are received by the Treasurer of this Association, they shall immediately be forwarded to the Accountant, Canadian National Live Stock Records, Ottawa, for deposit.

#### 13. CORPORATE SEAL

The seal as stamped in the margin hereof, shall be the corporate seal of the Association.

#### 14. REGISTRATION OF PEDIGREES

- (a) A Register shall be kept at the office of the Canadian National Live Stock Records. This register shall be called the Canadian Palomino Stud Book and shall be published by the Canadian National Live Stock Records at such time as decided by the Board of Directors and in such form as the information on office duplicates of certificates of registration issued, warrants.
- (b) There shall be furnished by the Canadian National Live Stock Records, for all living animals registered, a Certificate of Registration on the form adopted by the Canadian National Live Stock Record Committee. The pedigree shall be in such form as decided by the Board of Directors.
- (c) All certificates of registration shall be submitted for the approval of the officer appointed for that purpose by the Minister of Agriculture for Canada.
- (d) Any person suspended or expelled from membership shall not be allowed the privilege of recording pedigrees in the records of the Association.
- (e) Any person prohibited from recording pedigrees by any other organization incorporated under the Livestock Pedigree Act, shall not be allowed to record pedigrees in the Canadian Palomino Stud Book.
- (f) The Record Committee of the Canadian National Live Stock Record Board shall have power for any cause which in the opinion of the Committee seems proper, to refuse applications for registration or transfer from any person whether a member or not. Any such action taken by the Record Committee under this provision shall be immediately reported to this Association.

The Record Committee may refuse to accept the signature of any person on an application for registration or transfer whether a member or not, pending action of the Directors or a general meeting of this Association.

#### 15. IDENTIFICATION

The Board of Directors shall make regulations for practical and effective system of identification of all horses for registration.

#### 16. REGISTRATION OF NAMES

A breeder may register for his exclusive use a name to be used as a prefix in naming his animals. A particular name will be allowed to only one person or partnership only and in registering such names priority in use and in application for registration shall be considered. Letters shall not be used as a prefix to a name. Names shall not contain more than thirty letter spaces or characters including numeral affix. It shall not be permissible to change the name of an animal after it has been registered thirty days. In the event of a change in the name of a partnership or company or if any party is taken into partnership, the name may be transferred upon application to the Canadian National Live Stock Records by the registered owner or his authorized representative. Likewise the transfer may be made from a deceased owner to his heirs.

A registered name may be transferred to another person or persons on application of the person in whose name it is registered. After the expiration of five years a registered affix will be forfeited if it has not been used in registering an animal by the registered owner.

Animals from other countries shall be registered with the same name they had in the country from which they came.

The Association reserves the right to refuse any name which may be misleading or any name which may be misleading as to origin or relationship of an animal. The following names shall not be used:

Names of members of the Royal Family or leaders of national governments of the day.

Names of animals registered previously in this Stud Book.

Names whose spelling or pronunciation is similar to names already in use.

Names of famous horses.

Names registered by any breeder in this or in any other incorporated purebred livestock association in Canada.

#### 17. PRIVATE BREEDING RECORDS

There shall be kept by each breeder a private record which shall contain full particulars of his breeding operations. This record shall at all times be open to the inspection of officials of this Association, officials of the Department of Agriculture for Canada, and officials of the Canadian National Live Stock Records.

#### 18. STANDARDS FOR REGISTRATION

Standards for registration may from time to time and as occasion may require be made in a manner determined by the Board of Directors of this Association.

#### 19. SUSPENSIONS

## (a) Suspended Member

A suspended member is a member who has been suspended by the Board of Directors or who automatically suspends himself because he has not conformed to the Rules and Regulations of this Association, or who, as a member, has been placed on probation by the Record Committee of the Canadian National Live Stock Records.

#### (b) Suspended Registration

A suspended registration is a registration of pedigree or transfer that has been placed under suspension by the Board of Directors or by the Canadian National Live Stock Records on account of some irregularity. This suspension to remain until same has been lifted by the resolution of the Directors of this Association.

#### 20. RULES OF ELIGIBILITY

The following classifications of Palomino Horses will be accepted for registration when approved by the Directors of the Association:

(a) All Palominos recorded by the Palomino Horse Breeders of America, or the Palomino Horse Association and Stud Book Registry, Inc., of the United States, provided such horses are inspected and passed by inspectors authorized by this Association.

- (b) Animals will be accepted for registration which pass an official inspection and are of proper colour and good saddle type and conformation which have either the sire or the dam registered in the Canadian Palomino Stud Book or in one of the United States Stud Books listed in (a) or which are themselves recorded in the Stud Book of the Palomino Horse Breeders of America or the Palomino Horse Association and Stud Book Registry, Inc.
- (c) A filly foal one year of age or over or a colt two years of age or over of proper colour and good saddle type and conformation, as determined by an official inspection, whose sires and dams are recorded in the Canadian Palomino Stud Book.
- (d) Animals will be accepted for registration which pass an official inspection and are of proper colour and good saddle type and conformation and are by a sire of a breed incorporated under the Livestock Pedigree Act, namely, American Saddle Horse, Arabian, Quarter Horse, Morgan, Tennessee Walking Horse, Hackney, Thoroughbred, Standard Bred and any sire recognized by Palomino Horse Breeders Association and of any other breed approved by the Board of Directors of the Association and the Canada Department of Agriculture.
- (e) Ponies and draught horses, Appaloosa, Pinto, Albino or any other off colour individuals shall not be eligible. Qualifying colour markings will be of a golden body coat, that of an untarnished gold coin. Shades may vary lighter or darker. The body coat shall be free of patches of stain or blackened discolouration, a dorsal stripe or brown or black along the spine, zebra stripes of lighter or darker colour running around the body except white hair if caused by an injury. The mane and tail must be white with not more than 15% dark, sorrel or chestnut hair in either. The eyes must be the same colour and have black, brown or hazel irises. Glass eyes will be disqualified. White markings are allowed only on the face and/or on the legs where white on the front legs shall not extend above a line bisecting (equally dividing) the angle made when the knee is bent. Stocking must be below the knees or hocks except that on the front or inside of the rear legs the white may run to a continuous point up to six inches above the hocks.
- (f) The Board of Directors from time to time and as occasion may require, shall make regulations regarding the inspecting of all horses. The manner in which inspections shall be carried out shall not be inconsistent with the provisions of this Constitution.
- (g) The Board of Directors shall approve eligibility of inspectors who shall be under direct control of the Secretary of this Association and he shall arrange and direct the work of inspection.
- (h) A stallion, mare or gelding, that previously passed inspection and was recorded by the Palomino Horse Association of Canada, may be registered in the Canadian Palomino Stud Book:
- (1) On presentation of the Certificate issued by the Palomino Horse Association of Canada;
- (2) By payment of Annual Membership in the Canadian Palomino Horse Association amounting to \$15.00.

#### 21. APPLICATION FOR REGISTRATION

- (a) Applications for the registration of animals previously recorded in the Stud Books of those United States Associations as provided in Section 20 above, must be accompanied by the Certificate of Recording, duly transferred to the name of the Canadian applicant.
- (b) Applications for registration of animals born in Canada must be made by the person owning such animals on forms supplied without charge by the Canadian National Live Stock Records. All blank spaces must be filled in, in ink or typewritten, and the form must be signed in ink by breeder, owner, and owner of service sire.
- (c) Applications for registration must be accompanied by two clear photographs of sufficient size to show the animal distinctly. One photograph must show the left side and one the right side.

- (d) No application for registration will be accepted until and unless such application has been signed by the duly authorized inspector, vouching for the acceptability of the horse, in the matter of type, soundness and colour.
- (e) Applications for registration may be made at any time after an animal's birth but inspection and final registration will not be made until stallions have reached the age of two years and mares the age of one year.
- (f) When an animal is a twin, it shall be so stated when applying for registration and the sex given of the animal with which it is a twin. Should a twin be entered upon the record without such statement, no subsequent application for entry of animal twinned with same shall be accepted.
  - (g) No two animals shall have the same name.
- (h) The breeder of an animal is the owner or lessee of the dam at the time she was served. The first owner is the owner of the dam at the time the animal in question was born.

#### 22. TRANSFERS AND DUPLICATE CERTIFICATES

- 1. In case of the sale of an animal, the seller must furnish a certificate of registration in the Canadian Palomino Stud Book, showing the purchaser's ownership. Refusal to do so on any pretext whatsoever, except under written agreement to the contrary, shall be ground for his expulsion, if a member, from the Association, if not a member, further applications for registration or transfers shall be refused.
- 2. Applications for registration of change of ownership must be made in ink or typewritten on forms supplied by the Canadian National Live Stock Records and must give date of sale and date of delivery, and in the case of a female, if bred, service certificate must be completed. Change of ownership will be endorsed on the back of the original certificate of registration which must be forwarded to the Canadian National Live Stock Records with the application for transfer of ownership.
- 3. A duplicate certificate may be issued if the registered owner or his authorized agent files a statutory declaration on a form supplied by the Canadian National Live Stock Records, showing in a satisfactory manner that the original is lost, destroyed or unobtainable.
- 4. The Canadian National Live Stock Records shall have authority to accept an application for registration or transfer from the purchaser, provided it is established to the satisfaction of the Canadian National Live Stock Records that every effort has been made to comply with the regulations pertaining thereto.

#### 23. REGISTRATION AND MEMBERSHIP FEES

- 1. All fees should be paid to the Director, Canadian National Live Stock Records, and may be sent by post office money order, express money order, bank money order, or certified bank cheque, payable at par in Ottawa, Ontario, and they shall forthwith be deposited by him to the credit of the Association in a chartered bank selected by the Record Committee of the Canadian National Live Stock Record Board.
- 2. In case any fees are received by the Secretary or the Treasurer of this Association, they shall be immediately forwarded to the Director, Canadian National Live Stock Records, for deposit.

### 25. NON-MEMBERS

Any person not a member of this Association registering and transferring animals on the records of the Association shall be subject to the same rules and regulations as a member except as otherwise specifically provided for.

## 26. OFFENCES AND PENALTIES

1. Any member who violates any rule or regulation of the Society automatically suspends himself from making further registration or transfer.

- 2. Registration or transfer of ownership of an animal is made on the understanding that the particulars given on the application are correct. If it is subsequently discovered that the particulars given were incorrect or fraudulent, the registration or transfer shall be suspended by the Canadian National Live Stock Records and canceled by this Association. Pedigrees recorded incorrectly may be canceled and re-recorded by the owner or by the Canadian National Live Stock Records at the expense of the original applicant for registration or transfer, but it is understood that neither this Association nor the Canadian National Live Stock Records shall be held responsible for any loss or damage that may be sustained through suspension, cancellation or correction of any registration or transfer.
- 3. When as the result of an inspection of the manner in which private records are being kept and identification practised by any breeder, it is shown that the regulations in that regard as laid down herein are not being observed, the Board of Directors may immediately suspend or expel such breeder, if a member, and if not a member, further registrations and transfers may be refused, and if such inspection should indicate that the private records and identification system as practised by such breeder are in such a state of confusion as to raise a doubt as to the identity of any number or all of the animals in the stud, the Board of Directors may suspend the pedigrees of any number or all horses standing in the name of such breeder.

That Offences and Penalties as set forth in Sections 16 to 19 inclusive of the Livestock Pedigree Act, 1949, are applicable to all acts contrary to the regulations of the Association.

Section eleven hundred and forty-two of the Criminal Code shall not apply to any proceedings in respect of any offence under this Act.

Wherever the context permits in this Constitution, the singular shall include the plural and the masculine, the feminine and the neuter.
